Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2021-22 educational progress for Pansophia Academy. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2021-22 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2018-19. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2017-18. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2016-17. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

As shown in the AER report, our school tested low in the areas of math and reading. We have developed an expanded block of time for elementary students to participate in literacy instruction, which includes targeted intervention time using Fountas and Pinnell intervention and literacy essential resources. Reading and math opportunities have been expanded for our secondary students. Middle School students now have a longer block of english and math experiences available during the day. We are in year one of our curriculum re-alignment at the elementary level.

The continued focus and encouragement for the kids to attend our summer school program will also assist in the improvement of all subject areas. Our summer school experience now includes a Kindergarten Jump Start Program that occurs in late August. As outlined in the SIP report, a large focus is also being placed on professional development and continued training for our teachers.

State law requires that we also report additional information.

1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL

Early in the school year, Pansophia Academy has a designated time period for open enrollment. New families must enroll their child(ren) on or before the last day of the annual open enrollment period to ensure their child's placement in the Academy – OR – to ensure their child's placement on the waiting list if there are more students that want to enroll in the Academy than there are available seats.

Prior to the open enrollment period each year, all current Pansophia Academy students must re-enroll to attend the Academy the next year. During this period, siblings of current students not previously enrolled are allowed to enroll when and where space/seats permit.

The open enrollment period is announced to the public at the beginning of each year. For more information about the annual open enrollment procedures at Pansophia Academy, please contact an administrative assistant in the front office.

New students under the age of eighteen years old must be enrolled by their parent or legal guardian. Prior to enrolling, parents are strongly encouraged to participate in a guided tour of the Academy to obtain detailed information and ask questions. Upon acceptance, parents / guardians must provide copies of the following:

- Birth Certificate
- Proof of Residency
- Immunization Records

Homeless students who meet the Federal definition of homeless may enroll in the Academy. Such students will be under the direction of the Academy's Liaison for Homeless Children with regard to enrollment procedures.

A student who has been suspended or expelled by another public school may be denied admission to Pansophia Academy pending a review of the records. Prior to denying admission, the Principal will facilitate a thorough review, including an opportunity for a discussion between the parents and the Principal regarding the circumstances of the suspension or expulsion and any other factors the Principal determines to be relevant.

2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN

This SIP Team continues to meet monthly to monitor the status of the goals set in the plan. Pansophia is currently making progress towards all of its content goals and continues to improve upon all research-based strategies.

3. A BRIEF DESCRIPTION OF EACH SPECIALIZED SCHOOL

At this time, Pansophia Academy does not offer any specialized schools.

The curriculum at Pansophia Academy is correlated to the National Common Core. It is continually evaluated and evolving. Teachers work together to evaluate the curriculum at the end of each school year, and develop the curriculum at the beginning of the following school year. The curriculum is implemented in the classroom through direct instruction, small group instruction, group projects, and hands-on experiences.

5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS

In addition to M-STEP testing on our upper campus, the Academy uses the Northwest Evaluation Association (NWEA) assessment to assess student achievement in 1-8th grade. Students also receive formal classroom assessments, such as a comprehensive math assessment and spelling inventories, as well as i-Ready Diagnostic Assessments. The following data is related to the percent of students meeting our NWEA measurements in grades Kindergarten-8.

6. IDENTIFY THE NUMBER AND PERCENT OF STUDENTS REPRESENTED BY PARENTS AT PARENT-TEACHER CONFERENCES

- In 2018-2019, 238 parents participated in parent teacher conferences, which represented 61%.
- In 2019-2020, 201 parents participated in parent teacher conferences, which represented 53%.
- In 2020-2021, 128 parents participated in parent teacher conferences, which represented 34%.

7. FOR HIGH SCHOOLS, ONLY ALSO REPORT ON THE FOLLOWING:

1. THE NUMBER AND PERCENT OF POSTSECONDARY ENROLLMENTS (DUAL ENROLLMENT)

- i. In 2018-2019, 9 students enrolled, which is 26% of eligible 11th and 12th graders.
- ii. In 2019-2020, 3 students enrolled, which is 14% of eligible 11th and 12th graders. In 2019-2020, 12 students enrolled into early middle college, which is 20% of eligible 10th, 11th and 12th graders.
- iii. In 2020-2021, 4 students dual enrolled which is 7% of eligible 11th and 12th graders. 17 students were enrolled in Early Middle College which is 24% of eligible 10th, 11th, and 12th graders.

2. THE NUMBER OF COLLEGE EQUIVALENT COURSES OFFERED (AP/IB)

- i. Pansophia Academy did not offer college equivalent courses in the past four school years.

3. THE NUMBER AND PERCENTAGE OF STUDENTS ENROLLED IN COLLEGE EQUIVALENT COURSES (AP/IB)

- i. In 2019-2020 and 2020-2021 Pansophia Academy did not enroll any students in college equivalent courses.

- i. In the previous four school years, Pansophia Academy did not enroll any students in college equivalent courses, therefore, there were no students that received credit through this opportunity.
