We plan to work with the ELL team to provide additional academic support to close that gap.</p> <p>End of the Year Narrative:</p> <p>The aggregate and all subgroups of students showed progress toward the goal of 75% demonstrating proficiency in 2nd semester courses covering ELA and Math common core standards.
